she made as she worked with people in the final weeks of their lives. She says that when her patients talked about their regrets, a number of common themes surfaced again and again:

- **I wish I'd had the courage to live a life true to myself, *not the life others expected of me.***
- **I wish I hadn't worked so hard.**
- **I wish I'd had the courage to express my feelings.**
- **I wish I had stayed in touch with my friends.**
- **I wish that I had let myself be happier.**

The entire article is well worth reading for the additional insights it gives into each of these common regrets. One of my favorite quotes in the book is:

“Health brings a freedom very few realize until they no longer have it.”

If you were on your deathbed right now, what would your regrets be? What changes can you make today to ensure that when the time comes, you're not left wishing for a second chance to do all the truly important things you neglected?




